CREDIT COUNSELING AND DEBTOR EDUCATION COURSES

- ◆ You must complete the First Class (credit counseling) before we can file your case.
- ◆ You must complete a Second Class (pre-discharge/post bankruptcy debtor education) and also file the certificate with the court within 45 days of your 341 Hearing in order to receive a discharge.
- ◆ You will need to arrange payment directly with the credit counseling agency that you choose.
